REVISION OF CHAPTER CONSTITUTION AND BYLAWS

The chapter constitution and bylaws, last revised 10 years ago, underwent a complete review by the board of directors during the past two months. The recommended changes to bring them up to date with current policies and practices will be voted upon by the general membership present at the 15 November 2013 annual meeting. The recommended changes are contained in the following pages for the perusal of the general membership in advance of the annual meeting. It is requested that all voting members review the changes and be prepared to vote on them at the annual meeting.

The Cape Fear Chapter – MOAA Constitution and ByLaws Revision

Article II - Purposes

Proposed: "Preamble"

Rationale: Format change only. Should be noted that all format changes are to bring document more in line with the MOAA bylaws model.

Article IV - Membership and Voting Rights

Section 2b. Associate Members.

Proposed: Omitted

Rationale: Current MOAA policy limits membership to three classes, regular, auxiliary and honorary.

Section 2d. Honorary Members. (Current):

"(1) Those officials as determined by the Executive Committee such as the Post Commander, Fort Bragg, North Carolina, the Base Commander, Pope Air Force Base, North Carolina, and the mayors of Fayetteville, Spring Lake and Hope Mills, North Carolina."

Proposed:

"Section 4. Honorary membership shall be composed of individuals who have demonstrated significant support of the purposes of the Chapter and the Military Officers Association of America and are not otherwise eligible for membership."

Rationale: Examples are dated, suggestive and unnecessary.

Section 2e. Discrimination. (Current)

"No person because of race, color creed, sex, age, disability, or national origin will be unlawfully denied membership, be excluded from participation, or otherwise subjected to unlawful discrimination providing they otherwise meet the criteria for membership."

Proposed: Omitted

Rationale: Redundant and superfluous. Eligibility criteria is based solely on military service as a commissioned or warrant officer – active duty, retired, former or reserve components; such commissions tendered with constitutional protections against discrimination of any sort.

Section 5. (Current)

"Regular and [associate] members are *encouraged* to hold and maintain membership in the Military Officers Association of America."

Proposed:

"Regular members are *expected* to hold and maintain membership in the Military Officers Association of America. Auxiliary members holding Chapter offices are likewise expected to hold and maintain membership in the Military Officers Association of America. All auxiliary members are encouraged to hold and maintain such membership."

Rationale: Associate membership was discontinued. The change of the verb "encouraged "to "expected" is a compromise to the verb "required" which is the stricter policy preferred by the Military

Officers Association of America. Adopting the stricter policy would prove detrimental to the membership status of the chapter at this time.

Article VI – Dues

Section 1. (Current)

"Annual dues for members are established by the Executive Committee and are announced. Any required changes for the coming year will be determined prior to June 1."

Proposed:

"The annual dues for each member for the next calendar year shall be determined by the membership at the annual meeting in November after receiving the board of directors' recommendation in the matter, with the stipulation that dues for auxiliary members will be at half the rate of regular members."

Rationale: The setting of the dues structure for the chapter should be determined by the general membership based on the recommendations of the board of directors; and, that determination should be made at the November annual meeting.

Section 6. (Current)

"Auxiliary members are not required to pay dues."

Proposed: Omitted

Rationale: It is recommended that auxiliary members be assessed annual dues but at half the rate of regular members to justify their right to vote, hold elective office and avail themselves of all privileges of regular membership. Moreover, it provides an administrative mechanism to track and account for their status and helps defray expenses of newsletter printing, postage, and other costs.

Article VI – Meetings (Current)

"Section 1. Chapter business meetings or functions that may be sponsored by the Cape Fear Chapter MOAA Ladies Club will be held each month during the months of September through May. The annual Chapter meeting in November will include election of officers. The President can call special meetings with the concurrence of the Executive Committee.

Section 2. The rules in the current Robert's Rules of Order will govern the organization in all cases to which they are applicable and in which they are not inconsistent with these bylaws and any special rules of order the organization may adopt. Fifteen members at any meeting indicated in Section 1 above will constitute a quorum."

Proposed:

"Article VII - Chapter Meetings

Section 1. There shall be an annual meeting of the Chapter during the month of November to determine the annual dues for the next calendar year, to put forward a slate of candidates (on election years) to fill the positions of directors, and the transaction of other business. Notice of the meeting shall be mailed or emailed to each member at least 20 days in advance and posted to the Chapter's web site.

Section 2. Regular meetings of the Chapter shall be held in January, March, May, July, September, and November, unless otherwise decided by the board of directors. Notice of each meeting shall be mailed or emailed to each member at least 20 days in advance and posted to the Chapter's web site."

Rationale: To reduce the number and frequency of meetings to improve quality and attendance. Reference to the MOAA Ladies Club and its activities in this document is inappropriate in that it is a separate entity governed by its own bylaws and not structurally or legally linked to the chapter.

Article VII – "Executive Committee"

Proposed: "Board of Directors."

Rationale: To standardize the designation in accordance with Military Officers Association of America guidelines.

Section 1. (Current)

"The Executive Committee will be composed of the elected officers (president, first, second and third vicepresidents, secretary and treasurer) each of whom is entitled to one vote. The immediate past president, a non-voting member, will act in an advisory capacity. The president of the Cape Fear Chapter of MOAA Ladies Club will be an ex-officio member and provide liaison on matters involving the Chapter and the Ladies Club. Proxy voting will not be permitted."

Proposed:

"Section 1. The board of directors shall be composed of the elected officers: president, first vice president, second vice president, third vice president, secretary and treasurer. The immediate past president may serve as an advisor for a period not to exceed 1 year. The appointed positions of newsletter editor, auxiliary liaison, personal affairs officers, TOPS, chaplain, and legal advisor, plus other positions as determined necessary by the board of directors will likewise serve on the board as special staff at the pleasure of the president. The President of the Ladies Club of the Cape Fear Chapter of MOAA organization may be invited to sit as an ex officio member without vote to provide liaison on matters of mutual interest.

Section 2. The officers shall be elected biennially by the membership as outlined in ARTICLE IX, Section 10. Each elected officers shall take office at the first regular or special meeting in the calendar year following election and shall serve for a term of two years. The president may appoint individuals to fill the unexpired term of an elected officer or a vacant position as necessary until the next scheduled election. Such appointments will be approved by a majority vote of the board of directors."

Rationale: To codify current structure of the board and current practice of appointing members to fill elective positions between elections; to specify a discretionary period of service for the immediate past president.

Article VIII – Officers

Section 1. (Current)

"The elected officers will be a president, first, second, and third vice presidents, a secretary and a treasurer, each of whom will be a regular members of the organization."

Proposed:

"The elected officers shall be a president, a first vice president, a second vice president, a third vice president, a secretary and a treasurer, each of whom shall be a regular or auxiliary member of the Chapter."

Rationale: Auxiliary members are also authorized to hold elective positions.

Section 2. (Current)

"The president will appoint an officer nominating committee chairman. The appointed chairman will select two additional committee members so that the committee is representative of Chapter membership."

Section 3. (Current)

"The recommended slate of officers will be announced at the October meeting. Additional nominations may be called from the floor at the annual general meeting in November and a majority of the votes cast will elect. Each elected officer will be installed and take office at the following January meeting and serve for a two-year period."

Proposed: Article X - Committees

"Section 3. At least 60 days before the annual meeting on election years, the board of directors shall appoint a nominating committee of five members, not currently holding elective or appointive office, to nominate candidates for the elective offices. The committee shall notify the secretary in writing, at least 30 days before the annual meeting, of its proposed slate of officers and directors for the next calendar year, and the secretary shall list in the Chapter's newsletter and web site the nominated candidates for the elected offices, or mail or email a copy thereof to each regular and auxiliary member at least 20 days before the annual meeting."

Rationale: To specify that members of the nominating committee shall not be holding elective or appointive offices; to prescribe the time- line based on new bi-monthly meeting schedule, and notification processes using new informational technologies. Moreover, this provision should be more appropriately included in Article X – Committees.

Article IX – Committees and other appointments

Section 2. (Current)

"The committees identified below may be constituted:

Membership Committee Personal Affairs Committee Civic & Military Affairs Committee Programs Committee Publicity Committee Legislative Committee Budget Committee Bylaws Committee ROTC & Scholarship Committee

Proposed:

"Section 2. The standing committees of the Chapter shall include: membership, programs, ROTC and scholarships, personal affairs, legislative, and budget."

Rationale: To eliminate ambiguity and superfluousness.

Section 3. (Current)

"Should the Executive Committee determine that the day-to-day requirements of administering the organization justify as executive secretary, and funds are sufficient for appropriate compensation, a paid position may be established if approved by the Executive Committee.

Proposed. Omitted

Rationale: In conflict with Article III, Section 2.

Section 4. (Current)

"At his discretion the secretary may nominate one or more organization members to serve as assistant secretary (ies). Nominations are subject to the approval of the Executive Committee."

Proposed: Omitted

Rationale: Provision included in Article IX, Section 8.

CHAPLAIN'S CORNER

A fond farewell is extended to Chaplain (LTC) Ron Leininger who resigned as Chapter Chaplain because of a permanent change of station (PCS). Chaplain Leininger served as our chaplain from January 2012 to September 2013. A formal letter and a MOAA Certificate of Appreciation were presented to Chaplain Leininger as a token of our appreciation for his service. We wish him and his wife Alisa, God speed.

UNITED STATES NAVY (USN) CELEBRATES 238TH BIRTHDAY

The United States Navy (USN) is the naval warfare service branch of the United States Armed Forces. The US Navy recognizes 13 October 1775 as the date of its official establishment – the date of the passage of the resolution of the Continental Congress at Philadelphia, Pennsylvania that created the Continental Navy. On this day, Congress authorized the purchase of two vessels to be armed for a cruise against British merchant ships. It played a major role in the American Civil War by blockading the Confederacy and seizing control of its rivers. It played the central role in the World War II defeat of Japan. Today, the United States is the world's undisputed naval superpower.
