RECRUITING The MOAA National campaign, "Chapter Recruiting 2013," closed the month of November 2013 with 2,164 new members recruited nationwide since the first of the year, easily exceeding the annual goal of 2,000 as anticipated.

Although we contributed significantly to the MOAA National goal, we fell way short of achieving our own 2013 goal of 86. We finished the year with 53 gains; a respectable number nonetheless.

ABOVE AND BEYOND

The Sandhills State Veterans Cemetery Fund recently received a substantial donation from one of our chapter members, LTC (Ret) Dean Russell and his wife Mary.

In July, the NC General Assembly appropriated \$125,000 to upgrade the committal structure at the Veterans Cemetery at Spring Lake with the stipulation that the community was to raise a matching \$125,000 in donations.

At the 8 December Community Concerts screening of the documentary "Honor Flight" at the Crown Arena, Dean and Mary Russell were publicly recognized for their personal donation

of a matching \$125,000. Governor Pat McCrory was present to sign a ceremonial \$125,000 check to honor his commitment.

The Friends of the Sandhills State Veterans Cemetery are pursuing the funding to provide a place of dignity for veterans and their families to have funeral services for their loved ones at the cemetery in Spring Lake. When attending funerals at that site, families are sometimes exposed to inclement weather.

No one knows that better than Dean Russell who is also the Commander of the Cape Fear Chapter Honor Guard. The Honor Guard was established to pay respects and provide support to the families of deceased



chapter members upon request. The Honor Guard provides sentries at the casket or urn during the visitation, and serves as honorary pall bearers at the funeral service. Dean's membership in MOAA and his role as commander of the Cape Fear Chapter Honor Guard were highlighted during his introduction.

The Russell's unwavering support of our community and specifically our veterans is worthy of the highest esteem. The awareness of our chapter and MOAA in general they fashioned as a result of their benevolence is priceless. Thank you Dean and Mary!



As we enter into 2014 and make our yearly plans why don't we plan not just on a good year, but a good spiritual year or a year in which we experience God in a deeper more meaningful way? There is an old saying, which has been taught to military officers probably since there have been officers that is "if you fail to plan you plan to fail." I think we all can relate stories of this principle coming to fruition at some point in our own experience as well as in a lot of other places. It is also clear from Holy Scripture that God is a planner and wants us to plan. Moreover, I think He wants us to make our plans with Him in mind. In Proverbs 16:3 God's Word says, "Commit your works to the LORD. And your plans will be established."

A way to go out about making our plans for the year is to apply a principle referred to by ministers as the "law of the harvest." For those of you who are unfamiliar it may come across as a bit draconian or a bit overly agricultural, but here it is: "Do not be deceived: God is not mocked, for whatever one sows, that will he also reap. 8 For the one who sows to his own flesh will from the flesh reap corruption, but the one who sows to the Spirit will from the Spirit reap eternal life. 9 And let us not grow weary of doing good, for in due season we will reap, if we do not give up. 10 So then, as we have opportunity, let us do good to everyone, and especially to those who are of the household of faith." (Galatians 6:7-10)

Contained in the above overarching scheme of operations are three vital sub-principles: 1) Make sure that you are planting good things—i.e. true spiritual fruit (love, joy, peace, etc.). God in His Word will tell you what is good. 2) Don't give up the planting. Farmers know that everything that they plant is not going to come up just like military officers know that every initiative they attempt to execute is not going to come to fruition. Nevertheless, you can't give up or surely won't see good results. 3) Include your family and the family of God in your plans. In other words, don't make your plans focused only on yourself or your results will be severely limited.

WOUNDED WARRIOR "HOME FOR CHRISTMAS PROJECT"

The CFC sponsored a wounded warrior from the Wounded Transition Battalion at Fort Bragg as part of the Military Order of the Purple Heart "Home for Christmas Project."

President Juan Chavez presented a \$600 check on behalf of the CFC to SSG Adam Camp for travel expenses to his home in Memphis, Tennessee for the holidays. A total of 45 wounded warriors were similarly sponsored by various military and civilian community organizations.

SSG Camp was severely wounded in Kandahar Province, Afghanistan in 2010 when a .50 caliber machine gun was blown off its vehicle mount and struck him in the face. SSG Adam underwent five facial reconstructive surgeries at the LNC University Hospital the results



tive surgeries at the UNC University Hospital the results of which were simply phenomenal. He is now "ready to return to full duty" he said.

NCDMV APPLIES VETERAN DESIGNATION TO DRIVER LICENSES /ID CARDS

Effective October 7, 2013, NCDMV began offering the opportunity for veterans to request a veteran designation to be placed on their driver licenses and identification cards. This service can be obtained at any driver license office throughout the State. A DD Form 214 reflecting an honorable discharge must be presented when requesting a veteran designation.

The decal is affixed when the license is produced and all licenses are produced in Raleigh. There is a \$10.00 charge for this license as it is considered a duplicate license.

LEGISLATIVE BRIEF

SENATE PASSES BIPARTISAN BUDGET ACT OF 2013

On Wednesday, the Senate passed the Bipartisan Budget Act of 2013 (BBA) by a vote of 64-36. The two year budget deal includes a provision that reduces working age retirees' annual cost-of-living adjustment (COLA) by one percentage point until they reach the age of 62 – and fails to grandfather existing retirees and currently serving members who plan to serve a 20-plus year career.

Because of the fast-track nature of the bill, many members of Congress were caught off-guard by the overall financial impact retirees would face.

Servicemembers who retire at the 20 year point will feel the full negative financial impact of the provision by experiencing a near 20 percent reduction in their retired pay by the time they reach age 62.

For example, an E-7 retiring this year with 20 years of service would see an average loss of over \$3,700 per year by the time he/she reaches age 62 – overall impact: \$83,000 loss by age 62.

Even though the bill includes a COLA "catch-up" clause at age 62 that recalculates the follow-on retiree's annual pay base, the financial loss of the years between retirement and age 62 are permanently lost.

From the outset, the architects of the BBA insisted that the COLA adjustment would exempt disability retirees. After MOAA's review of the language, we discovered that it contains no exemption for Chapter 61 retired pay or for certain survivors' benefits.

Survivors of retirees under age 62 will see a reduced annuity; however, when their retiree would have reached age 62, the survivor's annuity will be recalculated to the full annual COLA.

This week MOAA, mobilized to voice our concern with the provision. The senate effort kicked off last Saturday with a conference call between MOAA President Vice Adm. Norb Ryan, USN (Ret) and Sens. Kelly Ayotte (R-N.H.) and Lindsey Graham (R-S.C.) to discuss the overall impact of the COLA cut.

On Sunday, MOAA organized a "Storming the Hill" event with our partners in The Military Coalition and The American Legion. Hill stormers visited every senate office on Monday urging them to strip the harmful provision.

On Tuesday, Admiral Ryan spoke at a press conference with Sens. Ayotte, Graham and Roger Wicker (R-Miss.) to explain the disastrous consequences of the retirement provision. Ryan stressed that MOAA did not want to prevent a bipartisan budget agreement, but implored the senate to find alternative funding to avoid disproportional cuts on the backs of military retirees.

Other budget-saving measures in the agreement include a provision altering retirement contribution amounts for federal retirees. However these provisions apply only prospectively to new hires, grandfathering current employees into their retirement system. Military retirees were not afforded this protection.

MOAA members launched over 188,000 messages sent to Capitol Hill in less than a week. Admiral Ryan stated, "We may have lost this round, but we have not lost the fight. The Senate Armed Services Committee leadership has vowed to take a look at this provision in January when the House and Senate return and we will hold them to it."

If not repealed, the provision goes into effect in December 2015
