# Chapter 'makes good' on pledge to raise funds for GWOT monument

s USA continues military operations in its 16<sup>th</sup> year in what many service members refer to as "our longest war," clearly one-third of the Cape Fear Chapter membership recently showed its support to the memory of the fallen by donating to the Chapter's Global War on Terrorism Monument Fund.

President Juan Chavez presented the final installment check to Don Talbot during the Chapter's board of directors meeting on July 5 at Fort Bragg's Iron Mike Conference Center. Don represented the Freedom Memorial Park Fund of Cumberland Community Foundation, Inc.

Mr. Talbot is considered the driving force in recognizing local citizens' military contributions with the establishment of Freedom Memorial Park (located at corner of Hay Street and Bragg Blvd., across from the Airborne and Special Operations Museum).

The park honors the fallen from past wars, declared and undeclared. The Global War on Terrorism deserves to be included in Freedom Memorial Park.

Musiol, currently assigned to the 82nd Airborne Division, was present at the ceremony.

This year's tournament will be held once again at Baywood Golf Course on Saturday, the 17<sup>th</sup> of September 2016. ## He Guided A Garrison, Now He Leads A Growing Municipality

ad Davis has a long list of accomplishments, military and ci-

vilian, to his credit, achieved in his US Army career and subsequently in the private sector and in public administration. Interviewed recently at his office in the Spring Lake Town Hall, where he serves as Town Manager, he spoke of his familial ties to the military, and how his Army career was the perfect preparation for the job he does now.

Like many members of the Cape Fear MOAA chapter, Davis' childhood was spent as an Army brat, moving from post to post.

He first saw Fort Bragg as a child. His grandfather and father before him, Davis is a 3d generation veteran of the 82d Airborne Division.

"I wanted to be a soldier like my father," he says. That motivation is evidently a part of his DNA, as he speaks with pride of the many military connections within his family. His father was a Citadel graduate, Davis himself went to West Point. He was, for a brief period, pondering the Navy as a career, having received an appointment to Annapolis before learning of the West Point opportunity. Davis' family ties to the military are very close to home – his wife, Diane, was among the Army's very first female aviators. They met at Hunter Army Airfield in Savannah and were married in the Main Post Chapel at Fort Bragg. The Davis' consider Fayetteville/Fort

Bragg home. Their two adult daughters live in Boston and Denver, which makes for some at-

tractive family reunion possibilities

It was during his stint as Fort Bragg' Garrison Commander (2001-2003 that Davis began to be become known by local leaders. Working with city and county leaders, as well as the highest levels of Army leadership, Davis led Fort Bragg through the abruptly-changed world following the 9/11 terrorist attacks. Subsequently, he worked with the US Army Reserve Command to move that headquarters from Atlanta to Fort Bragg during the Base Realignment and Clo-

sure process.

He's had some interesting challenges along the path of his career. Serving as the Deputy Drug Czar for Demand Reduction, he focused on the probably least recognized campaign in the drug war. Diminishing the evidently insatiable appetite for drugs among America's populace. More than advocating for "Just Say No" policy, Davis' work involved educating the public on the dangers of the rising level of THC in marijuana and the damage it could do to the still-formative brains of young people. They also recognized early the addictive properties of opioid drugs, recently acknowledged by even the medical profession as a danger to the public health.

Following his White House assignment, Tad was appointed by the President to serve as the Deputy Assistant Secretary of the Army for Environment, Safety, and Occupational Health. A position he held for five years leading the Army's global environmental, safety, and sustainability programs as well as DoD's \$18B (cost to complete) Formerly Used Defense Site (FUDS) cleanup program.

Upon his departure from the Pentagon (for the fifth time) he became the Chief Executive Officer of the U.S. Army Reserve Command, serving as the command's senior civilian with responsibility for relocating the command from Atlanta to Fort Bragg as well as providing executive oversight for more than 1,200 Army Reserve installations and facilities worldwide.

But now, back in the place considered home, Davis balances his work as the Town Manager of Spring Lake with other interests, such as the Cape Fear Chapter of MOAA. He schedules time to attend the monthly meetings, and acknowledges the organization faces some challenges in this new century.

"MOAA has to tell its story in a convincing way to potential members," Davis says. "Other military-related organizations are facing the challenges of diminishing membership and visibility within the community." Davis acknowledges that the Army itself has changed drastically over recent years. Developing a marketing plan for any military organization that

incorporates current realities is no easy task, he says.

Public service, however manifested, is a concept that Davis values highly. In the age of the volunteer Army, he feels that the combined privilege and burden of serving in the Armed Forces is no longer shared by the younger American population. He wonders if a short public service stint following high school graduation might be a way for young people to serve their country, and become acquainted with the concept of service and suspending the youthful tendency to focus on their own personal needs and aspirations.

Still relatively young, Davis is now in a career field known for its mobility. As well-credentialed as he is, other cities could very well court him to benefit from his experience and expertise. He says that's not something he thinks about.

"I'm just happy to be in Spring Lake," he says, "I want to make Spring Lake a wonderful place to live, work, play and worship for our citizens."

## From MOAA, Legislative Affairs

The House and Senate have both passed their versions of the FY17 Defense Authorization Bill, and they disagree on many important issues, including TRICARE fee hikes, housing allowance cuts, the military pay raise, and force levels.

**Health Care** - In the wake of last year's retirement reform, Armed Services Committee leaders are now focused on overhauling the military health care system.

The Senate would apply new and higher fees to current beneficiaries.

The House would grandfather currently serving and retired members and families against the large fee hikes.

Housing Allowances - The Senate bill would cap housing allowances at current BAH rates or the servicemember's actual housing cost, whichever is less, beginning with the first PCS after Jan. 1, 2018. That could have a big effect on many military homeowners. The Senate bill also would dramatically cut housing allowances for dual-military couples and other military sharers of housing by many thousands of dollars a year.

The House bill does not make any changes to housing allowances.

**Pay Raise** - The House bill provides servicemembers the full pay raise allowed by law - the same 2.1 percent pay raise experienced by the average American (as measured by the Employment Cost Index).

The Senate bill accepted the administration's proposal to cap the 2017 pay raise at 1.6 percent - which would be the fourth consecutive pay raise cutback.

**Force Levels -** The House bill increases force levels above the DoD budget request by 20,000 for the Army; 15,000 for Army National Guard; 10,000 for Army Reserve; 4,000 for the Air Force; and 3,000 for the Marine Corps, but reduces Navy forces by 4,500.

The Senate bill accepted all of the administration's proposals to cut force levels, including reducing the Army to 450,000, down from a wartime peak of 570,000.

**What's Next -** Lawmakers and their staffs already have had initial meetings to start resolving differences between the two bills.

Senate Armed Services Committee chair John McCain (R-Ariz.) has said he wants to complete action on the defense bill as quickly as possible.

Your grassroots input is needed to help influence the process.


# Mrs. Mary Henderson
