or those who were unable to attend our general membership meeting on 20 January and missed the "State of the Chapter" report you can view it in the "Documents" section of our website www.cfmoaa.org. Viewing the slides online, however, deprives the viewer of the narrative or discussion that goes with each. With that in mind, I want to elaborate on what I consider our most important goals for 2018.

Hep B is a killer for Viet Vets

ll of us are eligible for services at the VA Medical Center (VAMC) and many are receiving some services at the Fayetteville VAMC. There are some recent changes you should be aware of.

Last month we talked about agent orange. Statistics have now confirmed that Hepatitis B is much more prevalent among Vietnam vets, which is no surprise. Hep B is a slow killer and is very hard to treat. It is generally associated with bad water and in many places in the world that most of us have been.

The VA is starting a testing/treatment program soon to come on line. Everyone should be tested if you have not been in the past. More information will be coming soon.

Our local VAMC and Womack AMC are now combining/sharing, through the VA, hematology and oncology services that were only available in Durham. Orthopedic surgery, sleep medicine and vascular issues can now be seen locally. Hopefully you will not have need of these services. At this point your standard VA provider has the information. Unlike the agent orange program, you must have a VA provider for these programs.

We are awaiting more word on the reopening of the VA Emergency Room. There are a lot of obstacles in the way; it is not an easy issue.

Depending upon the specific law, the state holiday might officially celebrate Washington alone, Washington and Abraham Lincoln (whose birthday is February 12), or some other combination of U.S. presidents (such as Washington and the third president Thomas Jefferson, who was born in April). Bless my family, kindred, friends and country, be our God and guide this day and forever for His sake, who lay down in the

grave and arose again for us, Jesus Christ our Lord. Amen" (24 pages in his personal field notebook).

Surviving Spouse Corner: Ins and Outs of MOAA's Educational Assistance Program

Loans from the MOAA Scholarship Fund's Educational Assistance Program (EAP) are different from federal loans because they're private loans and interestfree.

This means you only pay back what you borrowed. Repayments do not start until four to five months after graduation, giving students time to get settled into post-graduate life before they start paying back the student loan.

Here are some important details and deadlines regarding applying for, renewing, and repaying the loan:

Applying

The application for the MOAA Scholarship Fund's EAP opens in November each year.

Students can apply for either the interest-free loan or the American Patriot Grant, which is for students whose military parent either died on active duty or was severely wounded. To be eligible for the programs, you must be the child of a currently serving, former, or retired officer or the child of a currently serving or retired enlisted servicemember; under 24 years old; entering or enrolled in a bachelor's degree program; and have at least a 3.0 GPA on a 4.0 grading scale.

If the applicant served in the military before applying or completing their college degree, then his or her age for eligibility extends by up to five years. Grandchildren do not have eligibility through their grandparents, and cadets at military academies are not eligible for a MOAA loan.

The student will be notified via email to check their semifinalist status. If selected as a semifinalist, a student must remember to send MOAA the appropriate supporting documentation. Sending in late semifinalist or finalist paperwork might mean you will not be eligible for the program.

If selected as a finalist, you will be notified via email mid-May and asked to complete a promissory note (signed by the student and military parent sponsor) and a direct deposit authorization form to let us know what bank account you would like us to deposit electronically your funds.

On the promissory note, you will need to provide the military parent sponsor's MOAA or Voices membership number. If a student is selected as a finalist, the officer parent is required to sign up for paid (Premium or Life) MOAA membership.

All other sponsoring parents will have to sign up for Voices for America's Troops (continued next page)

membership. These memberships must be maintained throughout the life of the student loan, including the repayment stage. Therefore, most of our members decide to sign up for MOAA Life Membership or three-year Voices Memberships, as they are the most cost-effective option.

If there are any issues with the disbursement, you will be contacted by MOAA. At the beginning of August, the first loan and grant disbursement is distributed for the fall semester, and the second loan disbursement goes out the first week of December.

Renewing

MOAA understands that as each school year ends, life becomes hectic with finals, trying to find housing for the next year, and moving out of the dorm. However, it is crucial to complete the online renewal form and send us official copies of your transcripts.

The MOAA Scholarship Fund EAP will contact students in early January regarding renewals. The online renewals must be submitted by March 1, and the official transcripts from the fall semester are due by March 31. Late submissions might delay or prevent the fall disbursement.

Repaying

Students graduating in May or June can expect a repayment packet to arrive during early summer at the address MOAA has on file.

Repayments do not begin until October. For those who graduate in the summer semester, repayment begins in January, and students who graduate in the fall will begin loan repayments in April. MOAA does offer

deferments of the student loan in special circumstances.

If you have information updates to your account, please notify us in order for the student loan payments to be processed. This includes, but is not limited to, mailing address, email address, marital status changes, bank accounts, and credit card updates. Parents of repaying graduates also must keep their MOAA or Voices membership active during the repayment period.

There are three ways graduates can repay their loan:

- 1. Call the MOAA Member Service Center at (800) 234-MOAA (6622) Monday through Friday from 8 a.m. to 6 p.m. Eastern time with their student number and pay via debit or credit card.
- Complete the automatic payment form, and send it to MOAA, which will allow the funds to be withdrawn automatically from an account or charged to a credit card.
- 3. Send a check to: MOAA Scholarship Fund EAP, PO Box 1854, Merrifield, VA 22116-8054





Excitement Builds for the New TRICARE Retiree Dental and Vision Plan

This week, MOAA had an exclusive preview of TRICARE's widely anticipated new dental and vision plans. This new insurance option for certain beneficiaries is set to be offered starting Jan. 1, 2019. The newly designed option was included in the 2017 National Defense Authorization Act with the legislated start date of 2019. The later starting time is meant to allow for better planning and communication for this new plan, as it will be offered and administered through the Federal Employees Dental and Vision Insurance Program (FEDVIP).

Here's the rundown on who is eligible for what. All TRICARE retirees and their families are eligible for both the dental insurance and the vision coverage. Active duty military families are only eligible for the vision coverage.

The FEDVIP dental program of offerings will replace the existing TRICARE Retiree Dental Plan, which is provided through Delta Dental. *That program will sunset Dec. 31, 2018*. Here's what will be offered. The retiree dental plan and the new addition of a vision plan will allow for beneficiaries to make a selection from among several dental and vision carriers with a variety of benefit options. For example, in 2018 the FEDVIP program lists 10 dental carriers and four vision carriers (Delta Dental is included) with comprehensive dental and vision insurance at competitive group rates.

Key facts:

- Eligible beneficiaries must choose their plan during TRICARE's open season, which is scheduled to be Nov. 12 Dec. 10, 2018.
- There will be no automatic transition for those beneficiaries currently enrolled in the TRICARE Retiree Dental Program. Beneficiaries will be required to enroll for coverage.
- Enrollment and plan changes can only occur during the open season with the exceptions for those beneficiaries with qualifying life events (usually anything that necessitates a change in the DEERS system).

Here's the kind of coverage TRICARE beneficiaries will get with FEDVIP (besides more choices):

- no wait period for most dental services;
- no annual maximum benefit for some dental plans;
- regional and national dental networks;

- no deductible for some vision plans;
- no limit on brands for frames or contacts for some vision plans; and
- discounts on LASIK offered by some vision plans.

Beneficiaries are encouraged to start getting information and pre-enrollment communications through the website set up just for this program. The website, www.TRICARE.benefeds.com will be up and running Feb. 1.

MOAA is working with the Office of Personnel Management, which oversees the administration of the federal employees benefit programs, to provide input on communication and feedback on the website, anticipate challenges, and brainstorm solutions for this newly available program for TRICARE beneficiaries.

When You Die, Will Your Spouse Be OK?

"When you die, will your spouse be ok financially?" If you haven't really thought this through, you need to. The difference to your surviving spouse is likely significant. There are two key aspects of the government's role in answering this question:

SBP is the Survivor Benefit Plan, a DoD life insurance annuity military retirees may buy to protect their family in case of their death. It can provide a survivor with a taxable annuity equal to 55 percent of a servicemember's military retired pay. If a servicemember dies on active duty, SBP payments are

automatic, and the surviving spouse receives 55 percent of what the member's retirement pay would be. SBP annuities are subject to taxation.

DIC is Dependency and Indemnity Compensation, a tax-free, monthly stipend paid by the VA to surviving spouses when a servicemember is killed in the line of duty, or when a former servicemember dies from service-connected causes. The current DIC rate is \$1,258 per month.

When you die, the government will help your surviving spouse if you fall into one of these categories:

- You are a retiree and you purchased SBP
- You are a retiree or veteran and your death is service-connected VA pays DIC
- You die on active duty
 automatic SBP and DIC for death in line of duty

Most active duty servicemembers are not aware of the programs discussed above; the same is probably true for veterans who are not retirees. Retirees, however, are more likely to understand the basics because they had to make a deliberate election to purchase or decline SBP. Still,

Currently, military survivors must forfeit \$1 of SBP for each \$1 of DIC they receive from the VA. MOAA believes that for service-caused deaths, DIC should be added to SBP, not deducted from it.

the complexities of SBP and DIC and who pays what baffle most — until a death. For many, this is where the lessons from the loss of a loved one begin.

Even though it is complicated, it is imperative you and your spouse understand SBP and DIC now — don't put this lesson off for your spouse to learn later. It's most important to understand that current legislation does not allow survivors to receive both SBP and DIC in full — even though Congress acknowledges these are two separate programs, paid out for two separate reasons.

This dilemma only applies to the survivors of retirees who purchased SBP or of servicemembers who die on active duty. For every \$1 of DIC, your spouse will need to surrender \$1 of SBP, up to the total amount of DIC (currently \$15,095 per year). In some cases, they might lose their entire SBP benefit, if the amount is lower than the DIC benefit. For example:

The scope of the problem is disturbing. Nearly 64,000 widows, spanning from their 20s to their 90s, are waiting for this inequity to be resolved. MOAA and others are working ardently to pass legislation to repeal this offset.

Congress has acknowledged this offset is not fair. Leaders have been vocal about their support, and they even approved the Special Survivor Indemnity Allowance (SSIA), currently \$310 a month, to mitigate

partially the offset. The Veterans' Disability Benefits Commission also concurs with MOAA that DIC should be paid in addition to SBP, not subtracted from it.

MOAA appreciates the support — but this is not enough.

Working as hard as we can, with dedicated people like you and members of Congress, we remain fenced by roadblocks solely because of funding.

We need every retiree who purchased SBP, and every active duty member, to act now. Do this for the 64,000 surviving spouses — and do it for your own spouse. We need Congress to find the funding to repeal this. Your spouse will appreciate not having to learn this particular lesson.
